Upon arrival, I met with Vikar Kidwai (Mosque Secretary) and Syeda Baqui (Victim). I spoke with Vikar who advised that on 07/12/19 Syeda hired someone to decorate the banquet hall in the basement of the Mosque for a party on 07/13/19. Vikar advised he had surveillance footage showing the offender, Faiyaz Hasan, removing the above listed items and removing them from the Mosque. Vikar advised that the Mosque staff made an announcement that the theft occurred after a prayer service prior to this report. Faiyaz spoke with the Mosque President, Fazal Mahmood, and admitted he removed the decorations. Faiyaz claimed he removed them because kids were hanging on them. Faiyaz offered to pay restitution. Vikar stated he was certain that Faiyaz was the person taking the decorations on the surveillance footage. He provided me as much contact information as he had. He also advised the Faiyaz is a member of the Mosque and was allowed to be in the Mosque at that time. However, Faiyaz was not authorized to remove the decorations.

I was unable to speak with Fazal at the time of this report.

I spoke with Syeda who related the following. She purchased the above listed items and provided me the approximate prices. She advised that she paid the decorator \$300.00 USC. She wishes to sign complaints.

I reviewed the surveillance footage at the Mosque. It shows Faiyaz enter the banquet area on 07/12/19 at 2113 hrs. He entered the hall with Mohammed Abdulsattar (Identified by Vikar) [REDACTED] Mohammed walks away from the area. Faiyaz walks up to and removes the decorations that were hanging and bundles them together. He then leaves.

Vikar provided me a copy of the surveillance footage on a DVD.

Vikar advised there is footage of Faiyaz leaving the Mosque with the items. He did not have this footage burned on a DVD yet. He advised he would bring it to DPPD when it is ready.

I recovered the DVD into the BEAST system.

I was unable to locate a birthday for Faiyaz via a LEADS search.

If the offender is located, Vikar wishes him to be issued a Trespass Warning for the Mosque.
